AMENDMENT AGREEMENT

This Amendment Agreement ("Amendment No. 3") to the Licence Agreement dated 22nd May, 2008 is made on this the 13th Day of April, 2022.

BETWEEN

Canara Bank, a body corporate constituted under the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970, having its Registered Office at 112, J.C. Road, Bangalore- 560002, Karnataka, India (hereinafter referred to as the "**Proprietor**");

AND

Canara HSBC Oriental Bank of Commerce Life Insurance Company Limited, a Company incorporated under the Companies Act, 1956, having its registered office at Unit No. 208, 2nd Floor, Kanchenjunga Building, 18 Barakhamba Road, New Delhi - 110001, India and Corporate Office at 139 P, Sector 44, Gurgaon-122003, Haryana (hereinafter referred to as the "**User**").

The Proprietor and User are collectively referred to as "Parties" and individually referred to as "Party".

WHEREAS:

- A. The Parties had entered into the Licence Agreement dated 22nd May, 2008 ("License Agreement") wherein among other things, the Proprietor had granted the User, a royalty-free, non-exclusive



licence to use its Registered Trade Mark/s mentioned in Schedule I of the License Agreement, in the form and manner provided in Schedule II thereof. The Parties under mutual understanding had subsequently amended the terms of the License Agreement vide amendment agreements dated 20th January, 2012 and 31st July, 2014. The License Agreement and the referred subsequent amendment agreements are collectively referred to as "Agreement".

- B. Per the agreed terms, the terms and conditions of the Agreement may only be amended by way of a written agreement signed on behalf of both the Parties.
- C. The Parties under mutual understanding are now desirous of entering into this Amendment No. 3 for the amendment of certain clauses and Schedule II to the Agreement.

NOW THEREFORE IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. This amendment is effective from date of execution.
2. That Clause 11 "Notices" of the Agreement stands amended and restated as follows:

3. That Schedule II of the Agreement stands amended and replaced with the Schedule II enclosed below.
4. It is agreed between the Parties that, the present Amendment No. 3 shall not affect the rights, liabilities and obligations of the Parties created or accrued prior to its execution.
5. That, for the purpose of this amendment, the terms unless defined herein shall have the same meaning as defined in the Agreement. The promises, covenants, agreements and declarations made and set forth herein are intended to and shall have the same force and effect as if set forth in Agreement.
6. This Amendment No.3 is supplemental to the Agreement and except as amended above all other provisions of the Agreement shall remain in full force and effect and continue to be binding on the Parties hereto.



IN ALL OTHER ASPECTS, THE TERMS & CONDITIONS OF THE AGREEMENT SHALL REMAIN UNCHANGED AND ARE HEREBY AGAIN RATIFIED AND RECONFIRMED BY THE PARTIES HERETO.
