From the CIO's Desk

Market commentary – February 2019

Equity markets were flat in the month of February 2019 after a positive start to the month. Markets were enthused by the interim budget while the RBI delivered a 25 bps cut in interest rates in the first week of the month. An increase in geopolitical tensions between India and Pakistan kept markets volatile even as global markets rose on optimism over US-China trade negotiations. We believe that situation would remain localised and not escalate much from here and thus should not be a matter of too much concern. After a gap, Foreign Institutions were net buyers to the tune of Rs 16,000 crores (approx.) of equities in the Indian markets.

However, GDP growth for 3QFY19 came in slower than trend growth at 6.6%. This was led by a slowdown in consumption, while, investments and export growth continued to improve. This increases the expectations for a further cut by RBI in interest rates in its next meeting in April 2019. Inflation continues to remain low with Consumer price inflation further moderating to 2.05% in January 2019. Industrial production growth strengthened to 2.4% in December 2019 after the November 2019 growth of 0.3%. We believe that slowdown in consumption was due to temporary credit tightening by NBFCs and would soon normalise as the tight liquidity conditions ease.

Interest rates also turned volatile as the month was marked by many high impact events. Budget surprised market positively by keeping fiscal deficit within expected band of 3.3%-3.5%. However, increase in gross borrowing was a negative surprise. After budget, RBI surprised market by delivering 25 bps interest rate cut. Towards the month end India-Pakistan geo political tensions caused another round of big wings in yields. The 10 year interest rate closed at 7.60% against previous close of 7.48% while crossing above 7.67% few times and month low of 7.42%. We continue to expect high volatility in interest rates but with significant downward bias. US Federal Reserve continues to indicate the willingness to go slow on interest rate increase and even change its policy stance to be accommodative. However, we believe that slowing global growth and benign commodity and oil prices are likely to keep interest rates lower, which is positive for capital gains in bond markets. Risks to the above view are Federal Reserve changing its stance, sharp rise in primary inflation, high crude oil prices and further tension between India and Pakistan.

The previous 4 years have witnessed several reforms- Goods & Service tax(GST), direct benefit transfer(DBT) of subsidies, insolvency and bankruptcy code, housing for all, thrust on "Make in India" etc. These reforms have created a favorable environment for economic growth in India. Long-term growth drivers, remain in place; these being a) recovery in domestic manufacturing and construction, b) strong 2019 outlook for bottom of pyramid consumption, c) expected bounce back in earnings growth, d) NPA recognition cycle ending, and f) a pick-up in capacity utilization, which should be a precursor to private capital expenditure revival. In our view, volatility is likely to continue in the short term till the general elections due by May 2019. We believe that this correction and volatility is a very good time to gradually invest and build a portfolio with a long-term horizon as outlook for growth is very good. Regular, systematic, and disciplined investments made during volatile times tend to earn higher returns in the longer term.

Our investment philosophy is based on a disciplined and structured approach of doing research and investing. It includes undiluted focus on fundamental research to identify high-quality businesses, having strong corporate governance framework that will create sustainable value for their shareholders. We employ great rigor and effort in identifying good companies and businesses and holding onto those investments for long periods. The objective is to build a portfolio of companies that will grow and become big over time and in the process generate superior returns.

After seeing the volatility in the markets in recent times, one may be tempted to cash out of the market-linked investments and wait for markets to stabilize. We would suggest that "time in the market is more important than timing the market" to generate good returns over a long-term period. Trying to time the market leads to negative surprises generally and investing on a regular basis is the best investment strategy. Regular investing in times like these leads to purchase of equities at attractive levels and generates superior returns over medium to long term.

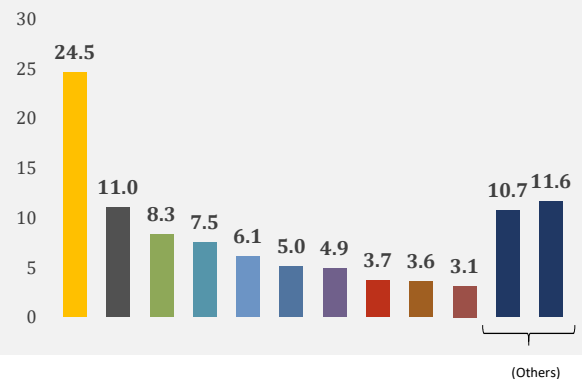

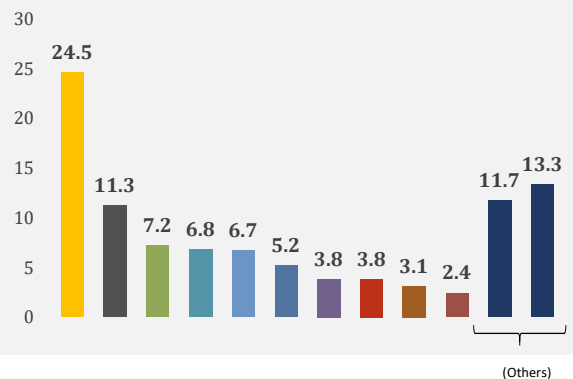

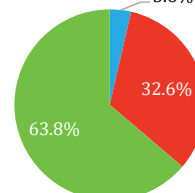
Top 10 Industry Sector Exposure (%)

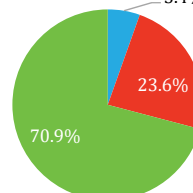
Top 10 Industry Sector Exposure (%)

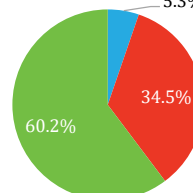
Top 10 Industry Sector Exposure (%)

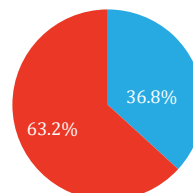
Top 10 Industry Sector Exposure (%)

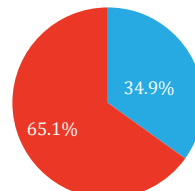
Top 10 Industry Sector Exposure (%)

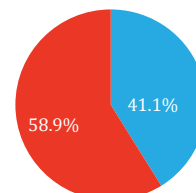
Top 10 Industry Sector Exposure (%)

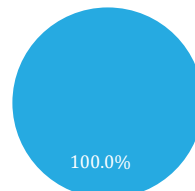
Top 10 Industry Sector Exposure (%)

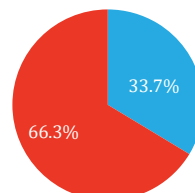
Top 10 Industry Sector Exposure (%)

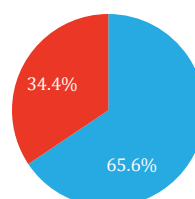

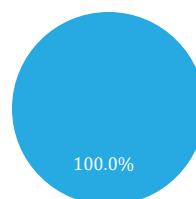
